The other units of competency, BSBWHS411, RIIRIS402E or BSBWHS414 must be held prior to obtaining or attempting this qualification.

Units of competency BSBWHS411 and RIIRIS402E or BSBWHS414 as well as RIIRIS501E must be obtained as a pre-requisite to sitting the DEMIRS "Statutory Managers' exam).
